

That I have surveyed, divided and mapped a parcel of land described below.

That I have made such Certified Survey under the direction of Verve, a Credit Union, bounded and described as follows:

Part of the Southwest 1/4 of the Northeast 1/4, Section 18, Township 17 North, Range 7 West, Village of Holmen, La Crosse County, Wisconsin being more particularly described as follows:

Commencing at the Northwest Corner of the Northeast 1/4, said Section 18; thence South 17°-40'-03" East, a distance of 1,453.36 feet to a point on the Southerly right-of-way line of Hale Drive, said point also being the point of beginning; thence South 00°-39'-25" East, a distance of 281.63 feet; thence South 89°-35'-27" East, a distance of 235.71 feet to the West line of Outlot 1 of Block 1 of Nicolai Flats Subdivision Plat recorded in the La Crosse County Register of Deeds office as Document No. 1511725; thence North 00°-18'-57" West along said West line, a distance of 281.05 feet to the Southerly right-of-way line of Hale Drive; thence North 89°-27'-26" West along said Southerly line, a distance of 237.39 feet to the point of beginning and containing 1.528 acres (66,542 sq. ft.) of land more or less.
